

**J-A-C ELECTRIC COOPERATIVE, INC.**  
**Membership Application and Electric Service Agreement**

The undersigned (hereinafter called "APPLICANT") hereby applies for electric service and membership in the **J-A-C ELECTRIC COOPERATIVE, INC.** (hereinafter called the "COOPERATIVE"), a Texas Cooperative Corporation, and hereby subscribes for membership in the COOPERATIVE, and in consideration of the acceptance of this application, the APPLICANT agrees with the COOPERATIVE as follows.

1. The APPLICANT will pay forthwith to the COOPERATIVE THE SUM OF TWENTY DOLLARS (\$20.00) in cash for one (1) refundable membership in the COOPERATIVE.
2. The acceptance of this application by the COOPERATIVE shall constitute an agreement between the APPLICANT AND THE COOPERATIVE, and the contract for electrical service shall continue in force from the date service is made available by the COOPERATIVE to the APPLICANT, and thereafter until cancelled under terms and conditions from time to time prescribed by the Board of Directors. Upon acceptance of this application by the COOPERATIVE, the copy of this agreement shall constitute evidence of that membership. No person or entity shall have more than one membership at any one time in the COOPERATIVE.
3. To receive and purchase from the COOPERATIVE all electric service to be purchased for use at premises owned, leased as lessor or lessee, occupied or used by the APPLICANT.
4. The APPLICANT represents that, prior to the time electric service is made available by the COOPERATIVE, APPLICANT's house and premises will be safely wired in accordance with the requirements of the National Electric Safety Code and National Electric Code as from time to time amended.
5. To be bound by and to comply with the COOPERATIVE's articles of incorporation, bylaws, consumer classifications, rates, charges, and service rules and regulations, both as the same now exist or may hereafter be adopted, rescinded, amended, or supplemented by resolution of the Board of Directors and where appropriate, approved by the Texas Public Utility Commission.
6. The APPLICANT agrees, as a condition of membership, to provide without charge to the COOPERATIVE, an easement of any real property needed by the COOPERATIVE for right of way for service or drop lines when such easement is deemed necessary by the COOPERATIVE in providing service to the APPLICANT or any other COOPERATIVE member or for any other need of the COOPERATIVE in constructing, operating, and maintaining its electric system.
7. The APPLICANT grants to the COOPERATIVE the right to offset any delinquent debts the APPLICANT may owe against any credits, capital accounts or refunds to which the APPLICANT may be entitled at any time. Failure for any reason to timely remit the funds necessary to pay for current electric energy charged to the APPLICANT will cause the APPLICANT to be delinquent. Payments must be received by the COOPERATIVE on or before 16 days of the date of the bill.
8. This application shall be considered a joint membership if subscribed to both husband and wife and shall constitute one (1) membership in the COOPERATIVE and shall be subject to the COOPERATIVE's bylaws pertaining to joint membership.
9. It is the policy of **J-A-C** Electric Cooperative to safeguard the privacy and confidentiality of member-consumer information, as outlined in our Policy on Privacy and Confidentiality. A copy of the policy is available upon request.
